### NEWS AND EVENTS REPORTED:

It might be recalled that the late James C. Ware, former State Senator, prominent Northern Kentucky attorney and community leader, past President of the Kentucky Historical Society, and member of the Kenton County Historical Society, passed away November 6, 1991.

The Dinsmore Foundation invited submission of abstracts of papers for the first of a series of planned symposia, entitled this year, The New Abundance: The Agricultural Revolution and the Shrinking World of the Nineteenth Century. This year's symposium was scheduled for October 15-18, the same dates as for Tall Stacks.

The Northern Kentucky Symphony held "A Night in Old Vienna" at the Oldenberg complex on February 23rd.

A meeting of the Northern Region of the Historical Confederation of Kentucky took place on Saturday, June 20 at the Boone County Public Library.

In conjunction with the Tall Stacks celebration scheduled for October 15 through October 18 on both sides of the Ohio river, and also to celebrate Kentucky's Bicentennial, the Behringer-Crawford Museum in March opened its exhibit entitled, "The Ohio River, Avenue of Change," which was to last throughout the remainder of the year.

The Boone County Preservation Office announced that on condition that enough orders were taken, there would be a reprint of the 1883 Boone-Kenton-Campbell Atlas for sale at \$15.00 plus \$4.00 for shipping.

The Northern Kentucky Historic Back Roads Tour booklet became available for \$5.00 plus \$2.00 postage through either the Northern Kentucky Convention and Visitors Bureau, or through the Behringer Crawford Museum.

On August 9, the Campbell County Historical and Genealogical Society held an open house for its new museum space on the second floor of the old Campbell County Courthouse in Alexandria. A Kentucky Bicentennial matching grant helped fund the renovation.

The City of Covington, Economic Development Office, initiated its Covington Historic Plaque program. Homeowners could research their homes and receive plaques from the City Commission which could be installed near the entrance. By September a number of citizens had already received their bronze markers.

The city's Economic Development Office (Ella I. Brown-Frye, Economic Development Director; Leah Konicki, Preservation Specialist) also published a workbook about history and architecture for children entitled <u>Discover Covington</u>, A Book for Children, 32 pages with maps, pictures, puzzles, illustrations available for \$3.50 through the city's Finance office.

On August 6, several members of the Kenton County Historical Society were on hand as the city unveiled its latest Historic Highway marker, this one to commemorate the city's "First City Hall," and located between Second and Third streets on the west side of Greenup in the new green space approaching the Roebling Suspension bridge.

On September 20 the Erlanger Historical Society sponsored Heritage Days in order to publicize renovation of the old Erlanger train depot, work on which this year, including relocation, was partly funded by a Bicentennial grant

In September the Behringer-Crawford Museum dedicated the emplacement of its life-sized flatboat exhibit. On November 1 the "Levassor Quartet" chamber music series was initiated.

There was much indexing of church records in 1992. Local genealogists, including Society members, consistently work very hard at special projects such as indexing, and at more regular investigations of family histories either for themselves or for others.

THE 1992 KENTUCKY BICENTENNIAL YEAR (SOME HIGHLIGHTS) On March 19, 1992 an ecumenical service was held at the Cathedral, Basilica of the Assumption, Covington, to salute Kentucky's 200th birthday; on June 10th a reception (with autographing by contributors) was held at NKU to welcome the publication of the Kentucky Encyclopedia; on July 18 there occurred the kickoff of the Northern Kentucky Back Roads Tour with ceremonies at selected sites in each of the three counties; from October 15 through October 18 the Tall Stacks spectacle, which also celebrated our river heritage, also highlighted the year; on November 15, to wind down the year's Bicentennial festivities, some 20 persons living and dead, from pioneer days to the present, were inducted into the Northern Kentucky Leadership Hall of Fame with ceremonies at NKU. This year the Kentucky Humanities Council also sponsored the Kentucky Chautauqua series, whereby speakers portrayed the personalities of famous Kentucky persons from the past. Dr. Leon Boothe, Pres. of NKU, chaired the Northern Kentucky Bicentennial Commission.
